About this grant

This grant is intended to support member businesses who are in need of financial assistance to undertake storefront improvements, equipment upgrades, critical repairs, rebranding or marketing initiatives. It will fund up to 100% of a project's expenses.

Section 1: Grant Details

The BIZ Support Fund will reimburse 100% of eligible costs towards your project up to a maximum of \$3,000.

All plans and proposed costs must be approved before the start of the project. Work undertaken prior to grant approval will not be reimbursed.

One deserving recipient will be chosen each year.

Projects must help a struggling business become more competitive, or maintain their existing operations in the face of unexpected hardship. Examples of eligible projects include: Critical equipment upgrades or unanticipated repairs, storefront or interior improvements, safety/security investments, rebranding and marketing initiatives, among others.

The BIZ reserves the right to determine the eligibility of all projects on a case-by-case basis. Applicants must be prepared to explain why they are unable to pay for the proposed project expenses themselves.

The applicant will be responsible for planning and coordinating all aspects of the proposed project. The BIZ will assist the recipient in paying for the improvements.

All applications will be reviewed on a first come, first serve basis. Applicants will be informed of their approval by the BIZ.
